**Permission to store a firearm in terms of Regulation
86(4) of the Firearms Control Regulations, 2004**

**INSTRUCTIONS: PERMISSION TO STORE A FIREARM IN TERMS OF REGULATION 86(4)
OF THE FIREARMS CONTROL REGULATIONS, 2004**

GENERAL INSTRUCTIONS

- The permission to store a firearm form must be completed in black ink that cannot be erased.
- The licence, permit or authorization holder of the firearm must complete Sections A and B.
- The licence holder with whom firearm will be stored must complete Section C.

SECTION A: DETAILS OF LICENCE, PERMIT OR AUTHORIZATION HOLDER OF FIREARM

1. **Full names**
The full names of the licence, permit or authorization holder must be recorded in paragraph A 1.
2. **Surname**
The surname of the licence, permit or authorization holder must be recorded in paragraph A 2.
3. **Identity number**
The identity number of the licence, permit or authorization holder must be recorded in paragraph A 3.
4. **Physical address**
The physical address where the licence, permit or authorization holder resides must be recorded in paragraph A 4.
5. **Postal code**
The postal code of the licence, permit or authorization holder's residential address must be recorded in paragraph A 5.
6. **Telephone number**
6.1 **Work:** The licence, permit or authorization holder's work telephone number, including the dialling code, (for example, (011) 577 5913) must be recorded in paragraph A 6.1.
6.2 **Home:** The licence, permit or authorization holder's home telephone number, including the dialling code, (for example, (011) 557 5912) must be recorded in paragraph A 6.2.
7. **Cellphone number**
The cellphone number (if applicable) of the licence, permit or authorization holder must be recorded in paragraph A 7.

SECTION B: DETAILS OF FIREARM TO BE STORED

1. **Date licence was issued**
The date on which the licence was issued must be recorded in paragraph B 1.
2. **Serial number**
The serial number of the firearm to be stored must be recorded in paragraph B 2.
3. **Make**
The make of the firearm to be stored must be recorded in paragraph B 3.
4. **Calibre**
The calibre of the firearm to be stored must be recorded in paragraph B 4.
5. **Action**

The action of the firearm to be stored must be recorded in paragraph B 5.

Person to whom permission was granted to:

6. **Name and surname of person who will store the firearm**
The name and surname of person who will store the firearm must be recorded in paragraph B 6.
7. **For the period**
The date on which and the date to which the firearm will be stored must be recorded in paragraph B 7.
8. **Reason for storage**
The reason(s) for storage must be recorded in paragraph B 8.

SECTION C: DETAILS OF LICENCE HOLDER WITH WHOM FIREARM WILL BE STORED

1. **Full names**
The full names of the licence holder with whom firearm will be stored must be recorded in paragraph C 1.
2. **Surname**
The surname of the licence holder with whom firearm will be stored must be recorded in paragraph C 2.
3. **Identity number**
The identity number of the licence holder with whom firearm will be stored must be recorded in paragraph C 3.
4. **Physical address**
The physical address where the licence holder with whom firearm will be stored resides must be recorded in paragraph C 4.
5. **Postal code**
The postal code of the licence holder with whom firearm will be stored residential address must be recorded in paragraph C 5.
6. **Telephone number**
6.1 **Work:** The work telephone number, including the dialling code, (for example, (011) 577 5913) of the licence holder with whom firearm will be stored must be recorded in paragraph C 6.1.
6.2 **Home:** The home telephone number, including the dialling code, (for example, (011) 557 5912) of the licence holder with whom firearm will be stored must be recorded in paragraph C 6.2.
7. **Cellphone number**
The cellphone number (if applicable) of the licence holder with whom firearm will be stored must be recorded in paragraph C 7.
8. **Date licence was issued**
The date on which the licence was issued must be recorded in paragraph C 8.
9. **Serial number**
The serial number of the firearm must be recorded in paragraph C 9.

10. Prescribed sags on premises?

Indicate your answer with an X in paragraph C 10.

THE LICENCE, PERMIT OR AUTHORIZATION HOLDER DECLARE THAT THE DETAILS PROVIDED BY HIM ON THIS FORM ARE TRUE AND CORRECT.

HE FURTHERMORE, DECLARE THAT HE KNOW IT IS AN OFFENCE IN TERMS OF SECTION 39(1)(F) ON THE FIREARMS CONTROL ACT (ACT NO 60 OF 2000) TO KNOWINGLY MAKE ANY FALSE STATEMENTS ON THIS FORM.

11. Signature of licence, permit or authorization holder

The licence, permit or authorization holder must sign in paragraph C 11.

12. Date

The date on which the licence, permit or authorization holder signs the form must be recorded in paragraph C 12.

13. Police station

The police station who inspected the safe must be recorded in paragraph C 13.

14. Date

The date on which the police station inspected the safe must be recorded in paragraph C 14.

15. Name of Designated Firearms Officer in block letters

The initials and surname (in block letters) of the Designated Firearms Officer who inspected the safe must be recorded in paragraph C 15.

16. Rank of Designated Firearms Officer in block letters

The rank (in block letters) of the Designated Firearms Officer who inspected the safe must be recorded in paragraph C 16.

17. Signature of Designated Firearms Officer

The signature of the Designated Firearms Officer who inspected the safe must be recorded in paragraph C 17.

18. Peral number of the Designated Firearms Officer

The SAPS Peral number of the Designated Firearms Officer who inspected the safe must be recorded in paragraph C 18.
